This service is subject to the following:

1. Mare shall be in a healthy and sound breeding condition.
2. If the mare aborts or fails to conceive, rebreed privileges will be available.
3. **Live Foal Guarantee:** Shall pertain to mares that are pronounced **Safe In Foal by a Veterinarian within 90 days** after the last breeding date. A live foal is defined as one that will stand and nurse. If the foal dies at birth, Mare Owner agrees to furnish Rainbow Bar Ranch, within 7 days, a veterinarian's certificate describing the occurrence. In such a case, rebreed privileges will be available.
4. If the mare dies or becomes unfit to breed, the Mare Owner may substitute a mare. Rebreed privileges will be available.
5. **Rebreed Privileges** are for the following year only. The breeding fee will not be refunded. If the Mare Owner fails to rebreed the following year, then any and all fees paid shall be forfeited, the right to rebreed is canceled and Rainbow Bar Ranch is released from all obligation of this contract.
6. If the above named stallion dies or becomes unfit for service for any reason, then this contract will be null and void and both parties are relieved of any further obligation. Any monies paid by Mare Owner toward the Breeding Fee, with the exception of the \$250.00 non-refundable Booking Fee that is included, shall be refunded to the Mare Owner if the mare is not settled or would qualify for rebreed privileges.
7. A semen shipment includes the collection, evaluation, and preparation of semen and the delivery to the courier (FedEx, UPS or Counter to Counter Airline) and all of the shipping charges. Rainbow Bar Ranch will pay all shipping charges and shipping insurance for delivery of the semen shipment container. In addition to the breeding fee the following semen collection fees and late charges may apply:
  - a. **New Contract:** First shipment included in stud fee. All other semen collection fees must be paid in advance by the Mare Owner at \$200.00 per event to:

**Rebreed:** All semen collection fees must be paid in advance by the Mare Owner at \$200.00 per event.
  - b. The Rainbow Bar Ranch semen shipping container must be **returned and received by** Rainbow Bar Ranch within 7 days of received shipment or \$25 per day late fee will be charged. A fee of \$250.00 will be assessed if the container is not returned to Rainbow Bar Ranch.
  - c. Counter to Counter Airline, Sunday, Holiday, and International shipping may be subject to additional fees.
8. Breeding Arrangements
  - a. The breeding fee and the non-refundable booking fee must be paid to Rainbow Bar Ranch before semen is shipped.
  - b. Rainbow Bar Ranch only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability or any costs arising from shipments delayed, damaged or lost in transit.
  - c. The Stallion will be collected on a schedule. It is the Mare Owner's responsibility to contact Rainbow Bar Ranch and become advised of that schedule.
  - d. The Mare Owner must give **24-hour advance** notice to Rainbow Bar Ranch prior to shipment. **All shipment requests must be cancelled by 9:00 AM (MST) the day of the shipment.**
  - e. Every effort will be made by Rainbow Bar Ranch to accommodate your mare's breeding time however mares at the farm have priority.
9. The Mare Owner agrees to comply with all appropriate Breed registry requirements concerning the use of cooled semen. Consequently, it is the Mare Owner's responsibility to return the signed Semen Collection / Insemination Certificate to Rainbow Bar Ranch and a signed copy to the registry.
10. A Breeder's Certificate will be issued for the foal when the mare has produced a live foal from this breeding and all expenses have been paid in full.

THIS SERVICE IS SUBJECT TO THE FOLLOWING:

1. Mare must be halter broke. Mare/foal shall be healthy and in sound condition, free from infections, contagious, or transmissible diseases. A current negative Coggins Test, veterinarian's health certificate, plus a worming and immunization record must accompany the mare. If they do not, Rainbow Bar Ranch's veterinarian will examine and/or test mare at Owner's expense. Rainbow Bar Ranch reserves the right to refuse service to any mare/foal not in proper condition.
2. Rainbow Bar Ranch agrees to diligently try to settle Owner's mare. The Mare Owner agrees to give the Rainbow Bar Ranch ample time to settle the mare. If for any reason the mare does not settle rebreed privileges will be available.
3. **Live Foal Guarantee:** Shall pertain only to mares that are pronounced **Safe In Foal by a Veterinarian within 90 days** after the last breeding date. A live foal is defined as one that will stand and nurse. If the foal dies at birth, Mare Owner agrees to furnish Rainbow Bar Ranch within 7 days, a veterinarian's certificate describing the occurrence. In such a case, rebreed privileges will be available.
4. If the mare dies or becomes unfit to breed, the Mare Owner may substitute a mare. Rebreed privileges will be available.
5. **Rebreed Privileges** are for the following year only. The breeding fee will not be refunded. If the Mare Owner fails to return the following year, then any and all fees paid shall be forfeited, the right to rebreed is canceled and stallion owner is released from all obligation of this contract.
6. If the above named stallion dies or becomes unfit for service for any reason, then this contract will be null and void and both parties are relieved of any further obligation. Any monies paid by Mare Owner toward the Breeding Fee, with the exception of the non-refundable Booking Fee that is included, shall be refunded to the Mare Owner if the mare is not settled or would qualify for rebreed privileges.
7. Mare Owner is responsible for all veterinarian fees. Before the mare leaves Rainbow Bar Ranch all unpaid board, expenses, and fees become due and payable.
8. A Breeder's Certificate will be issued for the foal when the mare has produced a live foal from this breeding and all expenses have been paid in full.
9. It is further agreed that Rainbow Bar Ranch shall not be held responsible for disease, accident, sickness or death of the mare and/or foal while under their care.
10. Rainbow Bar Ranch will not hold Mare Owner responsible for any disease, accident, or injury to their stallions, mares, or foals.
11. If for any reason the mare does not settle, the Mare Owner will hold stallion owner and Rainbow Bar Ranch harmless.
